A SAD FAREWELL TO A TRUE CHRISTIAN WARRIOR Obituary by Fr Christopher Basden

[It is with considerable sadness that I have to report that Daphne McLeod, a founding member of PEEP and my immediate successor as chairman, died aged 92 on Sunday 3rd January 2020, feast of the most Holy Name of Jesus. - Ed]

Daphne lived through the Revolution during and following the Second Vatican Council. As a teacher of Religion and then a Head Teacher at little St Joseph's, Upper Norwood, she endured the gradual decomposition of Catechetics in the 1960's and 70's

She often spoke first hand of the planned dismantling of the teaching of the faith. She experienced the utter Modernism of Corpus Christi College and its closure by Cardinal Heenan. Becoming the head of Pro Ecclesia et Pontifice she valiantly stood up to the ravages of the erosion of the treasure of the Faith by those who should have been its defenders.

Early on she picketed the infamous Bishop Rembert Weakland of Milwaukee who had been invited to the UK by the Hierarchy of England and Wales. This infuriated Bishop Hugh Lindsay who hosted him in Newcastle. The treatment she endured under Cardinal Hume and his successors are a dark page in the history of the Church in this country. *[I have on file the correspondence between Daphne and Cardinal Hume, and may well decide to publish it in a future Flock. It reveals in stark detail the utter corruption of the post-Conciliar British hierarchy - Ed]*

Tall, bright and articulate with shining clarity Daphne shone as the consummate teacher. Her indefatigable work in producing sound catechesis is bearing fruit to this day. We owe her so much because she transmitted the Traditional Catholic faith steadfastly in the face of the total failure of Catholic schools and Dioceses to do so. Courageous and resilient to the end she was taken care of at home in her final days by

IS WEARING A MASK A SIN?


When discussing the Covid hysteria with Covid cult members there are a couple of important facts to keep in mind. Firstly, total deaths per annum are irrelevant because they clearly are depended on population. The data to concentrate on is death rates, which is normally measured in annual deaths per million (DPM). DPM in 2020 in the UK were around 10,082 per million. Which, while up on 2019 was, nevertheless, lower than 3 out of 4 of the last 70 years, according to UN data.

Predictably, the Covid cult member will respond that you are heartless, because every one of those deaths mattered, which is just the sort of half-truth upon which cults build their belief systems. Given that the vast majority of Covid deaths occur in very old people who are seriously ill, in many cases these deaths will have been merciful releases. Your Covid cult friend will then respond, “*Well, my neighbour’s dog walker died and she was only 48*”. Which is like me saying that men are usually taller than women, and you responding, “*Well, one of my aunts was well over 6 feet tall*”.

The next bolt hole your friend will retreat to is, “*Well, the NHS is near collapse.*” The fact to note here is that the DPM in the UK is currently at an historical low. A mere 30 years ago, the DPM in the UK was around 2,500 times higher than at present - so if the NHS could cope back then, why can’t it cope now? The answer can only be (assuming the scaremongering is true) not increased demand but reduced capacity.

When Covid-19 reportedly first reached Britain, I was initially concerned, not hysterically so, but prudently so. However, within days my concern had began to morph into increasing scepticism. This scepticism was brought about by one eureka moment after another.

1st Eureka Moment: The Italian government put out a press statement that the average age of people dying *with* (not *from*) Covid-19 was 81! Further, over 99% of the alleged victims had comorbidities, indeed, the vast majority had more than one co-morbidity. 81 is actually older than the average life expectancy of 27 European countries! The moral of the story seemed to be: catch Covid and you will live a year or two longer on average than others! More seriously: since when did an incontinent



old man with dementia laying in a nursing home bed catching a chest infection and dying, constitute news let alone a cause for national alarm?

2nd Eureka Moment: The Italian government press-statement also stated that they had only lost two people under 40 to the virus, and both of these had serious underlying health issues. Yet according to the mainstream media, young Brits were dropping dead like flies. Clearly both these statements could not be true.

The outrageously cruel and mendacious nature of the mainstream media's coverage can be summed up in one report: the lead story on one occasion was a baby who had not survived 24-hours post birth because of Covid-19. An independent investigation into the story turned up the following facts: a young mother had gone into premature labour 22 weeks early. The child born at 18-weeks was too premature to survive - indeed, I would be surprised to learn that any child had survived that early. The medics then stuck a swab up the mother's nose, and found a trace of Covid-19 RNA based on a test that Boris himself now admits is unreliable! And this was the basis for the cruel lie broadcast by the Marxist activists pretending to be journalists who run much of the mainstream media.

3rd Eureka Moment: The mainstream media put out clips of Italian funeral directors in front of piles of coffins, and said funeral directors were, or so we were told, bewailing the fact that they were overwhelmed and could not cope. However, two Italian mates sent me the official government figures, which showed that less Italians had died in the first three months of 2020 than had died in the same period during the previous four years!

4th Eureka Moment: A Brazilian mate sent me a screen shot of Brazilian government statistics. Most people are unaware that Brazil is a federation of states, not too dissimilar to the USA. An analysis of the data revealed that the Marxist-led states were reporting a death rate that was over 50-fold greater than the pro-Bolsonaro (the Catholic president) led states! Now that again is just too ridiculous to be creditable.

Clearly, something very sinister is going on here. There were dozens more of these eureka moments (such as police protecting BLM rallies while baton charging anti-lockdown rallies, and big tech's ruthless censoring of doctors and scientists who dissented from the mainstream media's narrative), but you should get the gist.

Whilst my title, "Is Wearing a Mask a Sin?" is designed to be provocative, I am nevertheless making a serious point.

The "mask mandate" is the mechanism by which the Christophobic left and their allies, the Marxist activists pretending to be journalists in the mainstream media, have chosen to perpetuate the Covid-19 shamdem in the nation's collective subconscious, months after it has ceased to exist in reality. And cease to exist it has, as all the objective data clearly demonstrates.

Thus the mask mandate is the mechanism the state uses to prop up a lie, the lie that there is a deadly virus stalking the land, from which people are dying like flies and

wearing a piece of rag round your face will provide you with significant protection. That is not merely a lie, it is an obvious lie for anyone with more than a couple of brain cells to rub together. The mask mandate is the means used by the state to keep pouring jet fuel on the flames of the mass psychosis it has created. Therefore if one is wearing a mask, one is pro-actively co-operating in perpetuating a lie, and as Christ said, “The Devil is the father of lies.” And, leastways in my books, pro-actively, cowardly and lamely co-operating in propagating a hugely damaging lie is a sin.

Not: at the time of writing, more *fit* people have died from drowning in the UK than have supposedly died from Covid-19.

Sinister Scam No 1

We were originally sold the lockdown on the grounds that we needed to “flatten the curve” in order to save the NHS. Do you remember back in the days when they were building zillion bed hospitals all over the country and emptying NHS wards to cope with the rush. However, the naughty virus stubbornly refused to perform for its globalists ringmasters and the “rush” never happened. The zillion bed hospitals where quietly mothballed, and NHS nurses and doctors made videos of themselves basically prancing about doing nothing, and the “curve” in the UK was so flat for the next six months that you could play snooker on it. In fact, at the moment, young people have a higher chance of being stabbed in London than they have of dying from Covid-19.

Sinister Scam No 2

As the virus ran out of victims, our globalist ringmasters turned to “surging cases” as their next go-to strategy for keeping fear and the lockdowns alive. Note: not “cases” in the old fashioned sense of people who are actually ill - as in, “Sally’s taken to her bed with the flu” - but perfectly healthy people who, having had a totally pointless swab shoved up their nostrils, have been deemed to have had a brush with Covid-19 because they have detected a possible trace of its RNA in their body, among the trillions of viruses that exist in every healthy human body.

In other words, by “cases” politicians and fake news peddlers mean the discovery of widespread immunity in the general population - i.e. people who are not ill, will never need treatment, won’t need to be hospitalised and are not about to die - and whose “cases” would never have been discovered if not for the ridiculous and utterly pointless testing regime now in place. What possible purpose is served by testing people who are not ill other than to find “cases” in asymptomatic or mildly symptomatic people in order to keep the mass psychosis going and the lockdowns in place?

But again the naughty virus stubbornly refused to perform for its globalist ringmasters and, confounding the mainstream media panic narrative, even “cases” in this utterly dishonest sense were obstinately in decline toward zero as Covid-19, like every other viral illness that annually infects humans who live in temperate zones, inexorably wanes to vanishing point.

Sinister Scam No 3

With test now coming up almost empty on “cases” even in the dishonest sense they are using “cases”, politicians and the fake news have turned to “hotspots” and “surging cases” in a handful of British towns, meaning an irrelevant increase in positive test results among people who will not die, will not be hospitalized, and for the most will not have symptoms. In a sane world, of course, the discovery that a significant number of people in a given area now have immunity would be a cause for celebration.

Aside, the test they are using is patently unreliable (as now admitted by Boris Johnson). A taxi driver acquaintance sent away for a Covid-19 test kit. When it arrived, he carefully removed the swab from its sterile wrapping and placed it in the sterile phial provided for its return. He took no swab from himself and didn’t even allow it to touch the work surface. It came back positive - now there’s a surprise.

Sinister Scam No 4:

As daily deaths-per-day dwindle to zero, politicians and the fake news have resorted to reporting deaths in batches. This allows them to state, for example, “100 new deaths *reported* today,” thus creating the phony impression that 100 people *died* that actual day when the deaths actually occurred over a period of days or weeks or the-devil-alone-knows-how-long.

Sinister Scam No 5

A particularly evil scam that is beginning to surface, is the NHS telling people who have no symptoms and are as fit as the proverbial fiddle, but who have tested positive, that they may have serious problems later on, such as liver damage and more. This is pure evil because the NHS cannot possibly know this and has absolutely no reason to suspect this, for the very simple reason there has never been a “later on”. And further, this scam is based on a test procedure, which even its inventor has stated is not suitable for this purpose.

Sinister Scam No 6

The latest scam from the British government is to lump Covid-19 and flu deaths together. As we come into another winter, flu deaths will, of course, increase. By lumping the figures together they can keep the fear mongering going by claiming a “second wave.”

Sinister Scam No 7

As one scam after another loses credibility, politicians and the fake news have now realized that the muzzle is the only thing that can keep their circus on the road.

Thus, it should come as no surprise that in the USA, Joe Biden kicked off Kamala Harris’s Presidential campaign by announcing the first priority for the Democrats was not their usual demands for lots more abortions and more, better and safer sodomy, but rather a “nationwide mask mandate”! Yes, forcing millions of people to put diapers on their faces is now a major plank in the left’s platform. And this, notwithstanding

standing the fact that those telling us to wear muzzles are the same “experts” who were telling us that masks would only make things worse a mere couple of months ago! Move along folks - there’s nothing suspicious to see here.

The Centre for Disease Control in the USA warns: “*Don’t touch the face covering*, and, if you do, wash your hands or use hand sanitizer to disinfect.” New York City’s “face covering” advisory likewise warns: “*Wash your hands for 20 seconds with soap and water or use an alcohol-based hand sanitizer every time you put on and take off your face covering. If you are unable to clean your hands, be very careful not to touch your eyes, nose or mouth.*” New York City further warns that “face coverings” are such dangerous objects that they must not be left lying around the house: “*Do not put face coverings where others can touch them or where germs trapped in your face covering can touch other surfaces, such as counter tops or your kitchen table.*”

So what the left are now demanding is that we must be ordered to wear face coverings that have never been proven to limit viral spread and become so contaminated that one can’t even touch the damned things or leave them lying around lest someone else touch them. Everyone, however, must spend hours each day breathing through the very thing that cannot be touched because it is so contaminated - as if microbes that collect on its outer surface would not be inhaled by the wearer, including Covid-19. But it is especially important, say the lying demagogues, that not only every adult, but every *child* over the age of two be forced to breathe through contaminated pieces of cloth that must never be touched. And who is better equipped to follow this life-saving medical advice than a two-year-old?

Who, you may ask is driving this insanity? The answer is almost certainly The World Health Organisation (WHO) among others. Like so many things, the WHO is now in the hands of Marxist activists pretending, in this case, to be health professionals. If you need evidence: the WHO is currently campaigning for schools to teach 4-year-olds to masturbate and to be given the tools to explore their gender identity.

The WHO is currently run by one Tedros Gherbreyesus, a man who in a sane world would find it difficult to land a job flipping burgers in McDonalds. Tedros is a member of the politburo of the Tigray People’s Liberation Front (TPLF), a violent Marxist terrorist organization of the Tigray minority ethnic group (who “represent” just over 7% of the Ethiopian population), and he is not a medical doctor. The TPLF is part of a ruling coalition that has ruled Ethiopia for over a quarter of a century with an iron fist. The TPLF is listed in the U.S. Homeland Security Global Terrorism Database for a series of kidnappings, bombings and armed robberies, and Amnesty International has been denouncing its political violence for decades. Tedros rose through the ranks of this regime to become health minister (2005-2012) and foreign minister (2012-2016). In 2014, Tedros, organized the kidnapping, extradition and condemnation of several dissident leaders and hundreds of asylum seekers from Yemen.

China supported Tedros's rise to lead the WHO and keeps Tedros and the WHO on a tight leash. This probably has something to do with the fact that Ethiopia borrowed \$13 billions from China during Tedros' tenure as Ethiopia's foreign minister and the Chinese have developed nearly 70% of the Ethiopian infrastructure. But, given Tedros's Marxism, it should be no surprise we find him in bed with the Chinese Communist Party.

The WHO has form when it come to concealing disease outbreaks, in 2014, the WHO took nine weeks to declare the Ebola outbreak in West Africa an emergency, during which time 1,000 people had died. WHO kept the outbreak under wraps to appease African leaders.

And Tedros has also been personally accused of concealing outbreaks of disease. He is charged with covering up several cholera outbreaks in Ethiopia (2006, 2009, 2011) which ravaged the whole country when he was health minister, by relabeling them "*Acute Watery Diarrhoea*" - even when tests proved that the bacteria involved was that associated with cholera.

Tedros is also accused of helping Beijing hide the Coronavirus outbreak, openly praising the Chinese government, stating, "*China exemplifies new standards in epidemic preparedness and response.*" and then called the draconian quarantine measures taken by Beijing "*heroic*," while, at the same time, insisting that the rest of the world keep air traffic open with China. Taiwan (which is blocked from membership of the WHO by China) attempted to share information about the virus with the WHO in December but was pretty much "*ignored*."

In 2009, Tedros was also elected Chair of the Global Fund. The Global Fund is a partnership led by the Bill and Melinda Gates Foundation to fight AIDS, Tuberculosis and Malaria. In 2012, an audit of the Global Fund looked at several African countries, including Ethiopia, which had received \$1.3 billion in grants. The investigation showed a huge discrepancy between the results presented and the reality observed in Ethiopia on the ground: 77% of the medical centres did not have drinking water and 32% did not have sanitary facilities, only 14% had a microscope or a delivery table, and only 12% had a pharmacy.

Tedros and the TPLF have also been accused of genocide. The Amhara ethnic group (which make up 27.9% of the Ethiopian population) lost more than 2.5 million people in one decade, between the 1997 and 2007 censuses (nearly 8% of their population). They did not benefit from the same health services as the Tigray population (Tedros' tribe), except for a contraceptive campaign for which the Amhara appeared to have been top of the list. The Tigray population had 5 times better health coverage in terms of infrastructure and number of healthcare providers. Some of the contraceptive products pushed on the Amhara are restricted or even banned in Europe and the U.S.

How then did Tedros become the head of the WHO? Simple: the main funders of the WHO until yesterday were America and Bill Gates. President Trump has withdrawn American funding, thus Bill Gates, in effect, "owns" the WHO. The influence Bill

Gates has cannot be overstated, insiders say he is treated like a head of state, not only at the WHO, but also at the G20 summit. Tedros was Bill Gates favourite candidate, unsurprising given that they are both contraception peddling zealots. Tedros also has strong links to the Clinton Foundation, Dr. Fauci and the Chinese Communist Party.

It should now be obvious to us all that The Mask, that dirty thing one must not touch but only wear, never really had anything to do with health, much less “saving lives.” The Mask, like the cockade in the French Revolution is the badge of submission to the Masonic New World Order.

The 2020 American Presidential Election can be likened to me tossing a coin 100 times, with you watching, and it come down Trump 53 times and Biden 47 times, an entirely creditable result. You then suddenly usher me and all independent observers out the room and lock the door. Eight hours later you let us back in and announce that you have tossed the coin in our absence a further 100 times and it came down Biden 100 times. If you believe that you are either exceptionally dim or have absolutely no personal integrity. But don’t for goodness sake confess to suspecting some shenanigans here, you will be banned from Facebook, Twitter, Youtube, etc., and denounced by the left as a conspiratory nut job.

Who and what is driving the scamdemic? In a word: globalists. Globalists have form going back a couple of centuries. They are the Masons who plotted the French Revolution from their lodges, and planed the violent overthrow of Catholic order, slaughtering a third of a million Catholic peasants in the Vendée and elsewhere in the process. They are the Marxists who, financed and radicalised by Moscow, slaughtered over 7,000 Catholic priests, bishops, nuns and brothers in cold blood in Spain before General Franco unsheathed his sword in defence of Christian civilization. They are the Sturmabteilung (the Brown Shirts) who roamed the streets of Nazi Germany and - commanded by sodomites - beat up anyone who opposed the Nazis while providing security for approved political gatherings. Sections of our own police are morphing into units not dissimilar to the Sturmabteilung. Such units recently provided security for approved political



gatherings, such as a BLM protests, while baton charging unapproved political gatherings such as perfectly peaceful and good natured lockdown protests.

Who are the globalists? They are legion. The American deep state is full of them, as is the British Civil Service. The mainstream media is run by them, as is most of the press. If you have children who have been to university, unless they are exceptionally strong minded, they very probably have globalists leanings, for they will have spent four years being relentlessly indoctrinated by Marxist activists pretending to be educators. It is important to understand that Marxists, Masons and globalists are overlapping circles, or, put another way, are three sides of one triangle. Or better still: globalism is the agenda, Marxism is the soul, and the Masons are the brains of the behemoth.

There are some particularly pro-active globalists: the top-brass at the UN and the EU, big tech (the executives of Facebook, Twitter, Google, Youtube), George Soros, Bill Gates, Jeffrey Sachs, Warren Buffett, Kissingers, Gates, the Bloombergs, Bezos, Zuckerbergs, the Rockefellers, the Rothschilds, Bergoglio, Tedros (the Marxist who runs the World Health Organisation), the Communist government of China, Klaus Schwab the founder and executive chairman of the World Economic Forum, the Clintons, the Obamas, Dr Fouci, the British Secret Service and the British agent, Lord Mark Malloch Brown. On a lower rank are politicians like Macron, Merkel and our Boris.

Some readers may express surprise at the inclusion of the British Secret Service in the list, but the fingerprints of British Intelligence were all over the 4-year Russiagate scam. Sir Richard Dearlove (and his former underling, Christopher Steel) were allegedly prominent in shaping the “dodgy dossier” which fraudulently sort to bring Trump down. Strobe Talbot (the Oxford Rhodes Scholar) is alleged to have “sold” this fake dossier to member of the American Congress. The British Ambassador, Sir Darroch, was kicked out of the US by trump. The British entrapment operations that targeted General Michael Flynn as early as 2014 in London. The grubby paws of British Intelligence are everywhere.

What sets these globalist apart from the rest of us? Well, first up, they are undoubtedly mostly all sociopaths. For who else but a sociopath would want to be part of a cabal running the world from behind closed doors - rarely seeking election to anything - while plotting to manipulate and spread us ordinary folk around like we were merely Nutella on their toast? Who else but sociopaths would be willing to pass laws stopping ordinary people celebrating weddings, baptisms and funerals, or preventing us from visiting our loved ones in hospital, or forcing a thirteen year old to die alone without his parents at his bed side? - all on the back of an grossly overblown pandemic.

Next up, they are Christophobes. In fact, that is an understatement: they actually hate Christ with a white-hot intensity that suggest that their father is Satan. Consequently they hate Christendom and western civilisation in general. This is also why they cosy up to Islam, they are bound together by their shared hatred of Christians (Hitler also

admired Islam). It is also why they encourage mass immigration. Mass immigration is their orchestrated, stealth genocide of the Christian West. This hatred manifested itself in the French Revolution by giving quasi-religious names to the various means of killing Catholics: drowning us in the Loire was dubbed “Revolutionary Baptism” for example. The Marxist who sparked the Spanish Civil War would hold a crucifix before a priest and order him to spit on it, and when he refused they would kill him - even junior seminarians, i.e. children, suffered this fate. And some 10,000 priests died in Hitler’s death camps, including St Maximilian Kolbe.

Once you know who the leading globalist activists are, you start to spot all sorts of links, “coincidences” that are far too numerous to be accidents.

Dominion Voting Systems, the election software used to switch 100,000s votes from Trump to Biden was financed by Venezuela, Cuba and the Chinese Communist Party. Dominion is owned by Smartmatic. Peter V. Neffenger, Smartmatic’s Chairman, is second or third in command of a George Soros’ outfit and shares an office on the same floor in the same building (just another “coincidence” of course). And the guy who owns Dominion in the US is on Biden’s team.

But the key figure controlling Smartmatic allegedly is none other than our own Lord Malloch Brown. In 2014 Lord Malloch Brown (Knight of the Order of St George and St Michael), no ordinary British agent, was at the helm of SGO Corporation Ltd. SGO is a holding company and its main asset is Smartmatic. Just another “coincidence” of course. And Lord Malloch Brown is a former Vice Chairman of George Soros’ Investment Funds (just another “coincidence” of course) as well as Soros’ Open Society Institute and World Economic Forum, a former Vice President at the World Bank (1995 - 1999), UN Administrator for Development (1999-2005), UN Deputy Secretary General and UK Minister of State for Africa, Asia and the UN (2007-2009). These are just some of the hats that he has worn.

Since 2010 Smartmatic has been found to have been at the heart of election fraud in Mexico, Venezuela, the USA, and the Philippines. This led the IBON Foundation, a left-wing civil rights group in the Philippines, to describe Lord Malloch Brown, somewhat diplomatically, as, *“a foreigner who has made a career out of influencing elections.”*

The “coincidences” continue to pile up: Tedros, the Marxist who runs the WHO, is a mate of Bill Gates and the Chinese leadership. Tedros also has connections to the Clintons. Jeff Sachs, a rabid pro-abort waltzes in and out of the Vatican and is clearly a mate of Bergoglio. Pope Francis cruelly sells out his Chinese flock to the Chinese Communist Party. Boris’s and Chris Whitty’s rush to congratulating Biden on his victory, before a single American state had certified its results. Pope Frances writes encyclicals about climate change, currently a favourite theme of the globalists. Biden’s family take millions of dollars from Chinese companies linked to the Chinese Communist Party. When Sydney Powell a pro-Trump lawyer Tweeted that she had hard-evidence that Dominion Voting Systems was programmed to rig elections, Twitter suspended her account - all just “coincidence” of course.

Yet more of these pesky “coincidences”: a drug called Remdesivir, manufactured by Gilead Sciences, is now being trumpeted as the ultimate “cure” for Covid-19. The patent for Remdesivir is currently held by China through an agreement with Gilead’s drug patent sharing subsidiary called UNITAID. And UNITAID just happens to have an office near Wuhan, China. And can you guess who some major financial investors in UNITAID might be? Well, how about none other than George Soros, Bill and Melinda Gates, and the World Health Organization?

I know what you’re thinking! Just more “coincidence”! Well, here’s another “coincidence”: both Gilead Sciences and UNITAID were financial backers of Hilary Clinton in the last election.

And here’s another “coincidence”: Dr Fauci authorized millions of American dollars to be sent to the Wuhan Institute of Virology in China specifically for the study of Coronaviruses *after* those very same studies were deemed too dangerous to be continued in the USA. Oh, and did I mention that Dr Fauci’s wife works for Gilead Sciences?

THE LITURGY OF THE COPTS

Developed from a chapter in the book, The 21 (A Journey into the Land of Coptic Martyrs) by Martin Mosebach

Cardinal Newman famously wrote “To be deep in history is to cease to be a Protestant.” This statement came to mind when recently reading about the twenty-one Coptic Christians butchered on a Tunisian beach by “pious” Muslims in 2016. Actually twenty Copts plus one African Christian, Matthew - although the Copts have now adopted him as one of their own. More of this noble soul later. The word *Copt* is rooted in an ancient word that described a person from Egypt

The Coptic Christians trace the founding of their church to a missionary journey by the evangelist St Mark in the year 42AD. It is generally assumed that St Peter was illiterate and that Mark was his scribe. Mark became the first bishop of Alexandria. Tragically, the church broke with Rome sometime in the 5th century. Parts of the church have since returned to communion with Rome, so there are now in effect two Coptic churches. Importantly the Coptic church is orthodox (apart from the schism with Rome) and has a valid priesthood and a full sacramental life. The bishop of Alexandria, who heads the schismatic Copts, is also called “pope”. And, interestingly, is selected by ballot! - a shortlist of three names is placed in a vessel, and the “winner” is drawn out by a blind child. I think there could be some merit in that procedure - we could have been spared Bergoglio.

The Coptic attitude to the Scriptures is subtly different to the West’s. Which is best illustrated by the fact that they place readings from the Church Fathers alongside readings from the Scriptures in their liturgy. This public reverence for the writings of the Church fathers is something that could possibly enrich the Western Church.

What I wanted to focus on here is the Coptic Liturgy. Protestants deny the Real Presence of Christ in the Eucharist, but listen to the Coptic liturgy, and while doing so reflect on the fact that this is one of the oldest churches of Christendom, one that can traces its roots to St Mark the Evangelist and the year 42 AD, less than a decade after Christ’s crucifixion. The following is chanted or even shouted out impassionedly in ancient Greek, the sacred language of the Orthodox.

PRIEST: *He has instituted the great mystery and sacrament of His divinity for us, destined as He was to sacrifice Himself so that the world may live.*

PEOPLE: *We believe!*

PRIEST: *He took the bread in His holy, immaculate, venerable, and life-giving hands.*

PEOPLE: *We believe this is true. Amen!*

PRIEST: *He looked toward Heaven to you, O God, who are His Father and Lord of all creation, and expressed His thanks ...*

PEOPLE: *Amen!*

PRIEST: *He blessed it ...*

PEOPLE: *Amen!*

PRIEST: *He sanctified it ...*

PEOPLE: *Amen. We believe, we confess, we praise!*

PRIEST: *He broke it, gave it to His holy disciples and apostles, and said, "Take, eat: this is My Body, which is broken for you for the remission of sins. Do this in remembrance of Me."*

PEOPLE: *This is true! Amen.*

PRIEST: *Likewise, He took the chalice, after they had eaten, mingled wine and water in it, and expressed His thanks ...*

PEOPLE: *Amen!*

PRIEST: *He blessed it ...*

PEOPLE: *Amen!*

PRIEST: *And He sanctified it ...*

PEOPLE: *Amen! Again: we believe, we confess, and we praise!*

PRIEST: *He took a sip and the gave it to His holy disciples and apostles, saying, "Drink of it, all of you: this is My Blood of the new testament, which is shed for you and for many, for the remission of sins. Do this in remembrance of Me."*

PEOPLE: *This , too, is true! Amen.*

PRIEST: *Every time you eat of the bread and drink from this cup, you proclaim My death, confess My resurrection, and remember Me until I come again.*

PEOPLE: *Amen! Amen! Amen! We announce Your death, O Lord! We acknowledge Your holy resurrection and ascension! We praise You, we praise You, and we thank You, O Lord, our God!*

Shortly before Holy Communion, the priest stands before the offering and sings:

PRIEST: *The holy body and precious blood of Jesus Christ, Son of God. Amen.*

PEOPLE: *Amen!*

PRIEST: *The holy and precious body and true blood of Jesus Christ, Son of God. Amen.*

PEOPLE: *Amen!*

PRIEST: *The body and blood of Emmanuel, our God, that is the truth. Amen.*

PEOPLE: *I believe.*

PRIEST: Amen. Amen. *I believe, I believe, I believe! And I confess, to my last breath, that this is the life-giving body of your only begotten Son, our Lord, God, and Saviour, Jesus Christ, whom he received from our Lady, Mistress of us all, Blessed Mary, Mother of God. He made himself one with his divinity, without mixing humanity and divinity, without one affecting the other, and without altering the two Truly, I believe that his divinity parted not from his humanity for a single moment nor for the blink of an eye.... I believe, I believe, I believe that this is so in truth.*

At the moment of communion, Copts recall one of the most important stories of the Old Testament, the encounter between Moses and the burning bush in Sinai (Exodus 3:2-6)

And the Lord appeared to him in a flame of fire out of the midst of a bush: and he saw that the bush was on fire and was not burnt. And Moses said: I will go and see this great sight, why the bush is not burnt. And when the Lord saw that he went forward to see, he called to him out of the midst of the bush, and said: Moses, Moses. And he answered: Here I am. And he said: Come not nigh hither, put off the shoes from thy feet: for the place whereon thou standest is holy ground. And he said: I am the God of thy father, the God of Abraham, the God of Isaac, and the God of Jacob. Moses hid his face: for he durst not look at God.

For Copts, the burning bush is the Eucharistic Christ, thus everyone removes their shoes and the women cover their heads. Communion is taken by mouth under both forms. After receiving the host, the communicant holds a white cloth over his mouth so as to protect what he has just received until it is fully swallowed. In addition to the priests distributing communion (note: no special ministers) there is a deacon whose job it is to ensure no crumbs are dropped. If such should occur, the deacon goes down on his knees and picks it up with his lips.

For the Copts, liturgy and martyrdom were inseparably connected. The rite was the air they breathed, air is something those of us whom it is keeping alive only really think about when it is absent. But there was another layer to the community of the twenty-one. The priests who had visited them in Tunisia, before it became too dangerous, had described them as a choir, because, after work, they would often pass the time singing parts of the liturgy together. Western liturgy speaks of the “choir of martyrs.” The twenty-one had spent their lives preparing to join this choir.

The Coptic liturgy, the crucible that formed these martyrs, torpedoes both Protestantism and Novus Ordoism. For here we have a church founded by one of the writers of the four gospels within a decade of the Crucifixion, that offers Mass in a dead language facing the altar, a church that affirms its belief in the Real Presence of Our Lord in the Blessed Sacrament over and over in the most explicit language possible, and hails Christ’s mother as the Holy Mother of God.

MATTHEW THE “COPT”

In the year 303, Felix a Roman citizen was sentenced to death for being a Christian. On his way to his execution, he was spotted by a man who, moved by the sight of the holy martyr in chains, confessed his own Christian faith, and was beheaded alongside St Felix. This second man's name is unknown, so he is venerated by the Church as St Adauctus, which means "the added man".

The twenty Coptic Christians whose blood run into the sea at Sirte had there own "Adauctus" a young black man from Ghana. Very little is known of this man other then his name was Matthew. He was seemingly working alongside the Copts and was billeted with them. He had clearly bonded with them, and we can

well imagine him joining with them in their community singing in the evenings after work.

The Muslims, when they initially captured the men, wanted to release Matthew. But he protested that this would not be fair as he too was a Christian. We do not know whether he was a Catholic, a Protestant, Orthodox or whatever - but there are unlikely to be many Copts in Ghana. His kidnappers took him at his word and butchered him alongside his new found friends. The Coptic church has honoured his refusal to be separated from his Coptic friends and has adopted him as one of their own sons.

The only picture we currently have of Matthew is a still taken from the video made by his Islamic butchers, which show him kneeling in the sand in a orange jumpsuit. Unlike the Egyptians who were accompanied on their final journey by the prayers of their loved ones, no one in his homeland knew of Matthew's fate.

In the video, he looks both devoted and resigned, and he shows no sign of tension. He is probably the only one who would have understand the tirade of his executioners, delivered in English for the benefit of the camera. He kneels upright and holds his head high. He could have had no doubt about the gravity and hopelessness of his situation, but he clearly didn't see that as a justification for not holding his head high.

We are told that when his captors initially wanted to release him, Matthew simply responded, "I am a Christian." "I am a Christian" contains a liberating degree of objectivity. One becomes a Christian through baptism therefore every baptised person can proclaim, "I am a Christian." Even the most corrosive doubt cannot alter the efficacy of baptism. It seems that for Matthew it was all very simple: for Matthew his Christianity was as indisputable as his skin colour. Denying it would have struck him, not so much as a betrayal, but as simply pointless. His would-be butchers had

just not looked close enough when they tried to let him go, because on closer inspection it might as well have been written on his forehead.

The black man calmly kneeling on the beech in quiet anticipation of the knife that will sever his neck, is the son, not just of another land but of another age, an age that has long sank into a distant and forgotten history - a time when people knew exactly who they were, and trusted that language actually expressed reality. Accounts of people declaring, "I am a Christian" when they knew the consequences would be a certain, cruel death have a mythical ring to our modern ears. Some might be tempted to believe that no one thinks that way anymore, had not Matthew's blood flowed into the sea at Sirte.

It is possible, of course, that Matthew wasn't baptised, but no matter, by his willingness to die for Christ alongside his Coptic friends, he received the baptism of blood: his own blood replaced both the holy water and the priest's christening.

FRATELLI TUTTI

Pope Francis pleases the world – and trashes Catholicism

Fratelli Tutti, Pope Francis's latest encyclical containing 43,000 words, has nothing to do with a well-known variety of Italian ice cream, although some loyal Catholics may be forgiven for crediting the traditional *Tutti Frutti* dessert with more depth, substance and meaning than the latest offering from the Holy Father. *Fratelli Tutti*, though, like the ice cream, is sweet, gooey and inoffensive to the modern mind. Who could argue, for example, with the sugary statement that '*everyone has a fundamental role to play in a single great creative project: to write a new page of history, a page full of hope, peace and reconciliation*' or perhaps this one: '*If only we could view our political opponents or neighbours in the same way that we view our children or our spouse, mother or father! How good would this be!*' Yeah!

So what is the Pope there for? In order to get to the bottom of this crisis of teaching it is necessary to establish the original contract of employment between God and the Holy See. Put briefly, the Pope is under a dual obligation: firstly to defend the Faith and, secondly, to confirm his brethren. He is Christ's vicar on earth and tradition tells us that the reason the Pope uses the royal "we" in his utterings (or used to at any rate) is because, to paraphrase Bishop Fulton Sheen, he speaks in union with his divine master who is Christ himself. Even Jesus Christ was not at liberty to change one word of teaching as it came from his Father in Heaven. "My teaching is not my own but from my Father who sent me." (John 7:16) Even for the majority of people who know nothing about religion and care even less, the logic of the basic authority of the Pope is plain to see.

If the Pope makes a statement which is at variance with Catholic teaching he may be applauded on social media and elsewhere but if the Church is universal and is divine, which it has always claimed, (St Thomas calls it the perfect society because it includes Purgatory and Heaven) then its teachings are also universal and applicable to

all men and women of every time. It follows from this that to depart from them, as I'll demonstrate Francis has done in *Fratelli Tutti*, is to make a nonsense of the whole concept of doctrinal purity and causes utter confusion in the minds of good Catholics. It is this argument which is currently swelling the ranks of *Sedevacantist* groups who concluded long ago that the see of Peter is vacant and Pope Francis is an imposter. There's not enough space to examine this claim but it is sufficient to say that you cannot really blame people who take this view.

All this begs the question: how does Pope Francis depart from Catholic teaching in *Fratelli Tutti*? Leaving aside the ‘pie-in-the-sky’ and totally unrealistic utterings about universal brotherhood there are more serious issues to be addressed. They are whether His Holiness has denied, contradicted or questioned infallible Catholic teachings. I would maintain that he has done this in several places in his encyclical. As a starting point it is worth stating that if some enlightened Catholic layman were to explain some of the infallible teachings to Pope Francis, he would probably be deeply shocked and perturbed. This assumes that he is ignorant of fundamental Church teaching which is the charitable way of looking at things. One of these doctrines is that non-Catholic religions are false and offensive to God. Sorry folks, that's Church teaching! Until Vatican II all Catholics believed this but the Church has always preached tolerance in terms of ‘live and let live’ and maintained a vast missionary department spreading all over the world to make converts. In paragraph 277 Francis proclaims ‘The Church esteems the ways in which God works in other religions (and) rejects nothing of what is true and holy in these religions.’ Archbishop Vigano, in hiding and fearing for his life because he exposed Vatican corruption, has said recently that this statement is “gravely equivocal and deceptive, more insidious than a blatant heresy.” Another universal doctrine is that God loves us in proportion to our acceptance and love of him. But Francis states: (Para 281) “And God’s love is the same for everyone, regardless of religion. Even if they are atheists, his love is the same.” This statement, warming though it sounds, isn’t Catholic, not by any stretch of the imagination. What we need to know is whether the Holy Father is indeed ignorant of Church teaching because if he is not, then he has some explaining to do and Archbishop Vigano has even called for him to resign. It is better to be ignorant than heretical perhaps.

Two shocking statements of Catholic teaching are enough for now as they are hard to take in without the aid of a stiff single malt . The Pope’s espousal of the principles of the French revolution, liberty, equality and fraternity, in para 219, does not ring true given the blood fest resulting from that historical event (not to mention the wholesale murder of Catholic priests) and verges on bad taste.

This universal brotherhood of man lark has been tried many, many times before in history. It’s in most communist manifestoes and the American constitution. There was a famous pop group by the same name and John Lennon mentions it in *Imagine*. This notion of brotherhood has been responsible for more deaths and incarcerations than any religion because an unfortunate side effect is that it only applies to people who agree with the authorities, including Pope Francis. His repeated calls for fraternal

brotherhood call to mind his own unfortunate record in this sphere. In his excellent book, *The Dictator Pope – The inside story of the Francis papacy* (Regenergy Publishing 2018), Henry Sire catalogues his personal experiences of working in the high octane and deadly atmosphere that is the Vatican under Francis. One priest in the curia, notes Sire, observed that “They say it’s not what you know but whom you know. In the Vatican that isn’t true: it’s what you know about whom you know.” Sire notes (P.184) that ‘Fear is the dominant note in the Curia under Francis’s rule.’ In order to pursue his political (and it is political) agenda Francis has been ruthless in his attacks on Catholics and Catholic institutions. This is particularly evident when one examines his trashing of the prayerful *Franciscans of the Immaculate*, and all because these monks and nuns largely preferred the Latin Mass. This institution has been almost completely destroyed including its printing press, its seminaries and communities and all because they did not fit in with the Pope’s ideological view of the world. His onslaught against this order dedicated to St Francis of Assisi is particularly odd given His Holiness’s identification with that saint throughout *Fratelli Tutti*. Ordinary Traditional Catholics are beginning to tire of his ceaseless and ill-intentioned public verbal attacks on them, such as accusing them of “seeking to safeguard the ashes of the past” (Interview on a flight from Rumania in 2019) and “no need to breed like rabbits” (interview on a flight from the Philippines in 2015) His open threats against Archbishop Vigano were sufficient to drive this innocent prelate into hiding.

The Pope’s pre-emptive strike against the Trappist monastery of Mariawald in Bavaria in 2018 was utterly ruthless. Here a thriving community was dispersed by direct order of Francis and its treasures auctioned off. All because the monks, like the Franciscans of the Immaculate, preferred the Latin Mass.

As Pope Francis continues to force his peacenik agenda on the world simple loyal Catholics see this encyclical as the precursor to sterner measures designed to shut down and silence once and for all the opponents of the revolution which is inspired by the *Mein Kampf* of The Second Vatican Council (1962-1965) This is the basic problem; Vatican II. This delinquent council is in complete harmony with the Pope Francis revolution and *Fratelli Tutti* makes numerous references to the council, especially the document *Nostra Aetate* which, as most discerning Catholics know but will not admit, represents a striking departure from authentic Church teaching. Needless to say no reference is made to any Popes before the Beatles era and especially not the great 19th century pontiffs who went to heroic lengths to denounce the ideas of Pope Francis. Oh yes, the ideology of *Fratelli Tutti* is old hat and its principles have been condemned before and many times over.

This encyclical above all demonstrates the utter irrelevance of the Catholic Church to the human condition nowadays. EFFECTS OF CENTURIES OF INBREEDING AMONG MUSLIMS: LOW IQ, VIOLENCE AND TERRORISM

Almost half of Muslims are inbred. How does that affect intelligence and health? And is there a connection to terrorism and violence?

Lise Egholm, long time school leader in the Muslim dominated area of Nørrebro in Copenhagen, Denmark, recently warned against not talking about the widespread practice of inbreeding among Muslims: “*A study shows that infant mortality doubles along with a high risk of congenital malformations, also that increased birth defect rates and inheritance of recessive traits are more common in consanguineous marriages. I think it's time to express concern. We must talk about this problem. All parents want healthy children. Fortunately, we live in a society where our health system does much to ensure that a pregnancy ends with a viable child. What amazes me and has made me wonder for years is why we do not talk about, maybe even ban, the many cousin marriages?*”



While health systems in otherwise less developed countries in the Muslim world are openly discussing and warning against consanguineous marriages, it is considered politically incorrect in the West to problematize the vast genetic and societal problems resulting from this religious-cultural practise.

Prevalence: Statistical research on Arabic countries shows that up to 34 percent of all marriages in Algiers are consanguineous (cousin marriages), 46 percent in Bahrain, 33 percent in Egypt, 80 percent in Nubia (southern area in Egypt), 60 percent in Iraq, 64 percent in Jordan, 64 percent in Kuwait, 42 percent in Lebanon, 48 percent in Libya, 47 percent in Mauritania, 54 percent in Qatar, 67 percent in Saudi Arabia, 63 percent in Sudan, 40 percent in Syria, 39 percent in Tunisia, 54 percent in the United Arabic Emirates and 45 percent in Yemen (Reproductive Health Journal, 2009 Consanguinity and reproductive health among Arabs). In Pakistan 70 percent of marriages are consanguineous and in Turkey the percentage is 25-30. There seems to be no national data on Indonesia, but there are reports of 17 percent consanguinity in East Timor and a “*high level of consanguineous marriages in some areas of Java.*”

Except for a few exceptions like Indonesia and Albania, roughly half of the population in the Islamic world is inbred, in most cases for generations.

Religion: The reason is partly religious. Muhammed himself married his cousin and according to the Quran, Allah allows sexual relationships between cousins (Quran 4:23-24).

According to Islamic law, Sharia, family honour is dependent upon the ability to control family members, which is another reason for keeping daughters inside their own blood-related family when marrying.

Sharia law's extreme restrictions on women's freedom of movement and contact with men probably also makes it more likely to marry one of the few men they are actually allowed to interact with.

Health and intelligence: A long list of mental and physical complications are related to inbreeding between cousins. These include an increased risk of depression, schizophrenia, and mental retardation. Mental retardation (an IQ of less than 69) in children of consanguineous marriages is five times more frequent than in normal marriages. On average, cousin marriages results in children with 10-16 points lower IQ. Social abilities, including empathy, are also less developed with inbred people.

The cognitive consequences of Muslim inbreeding might explain why non-Western immigrants are more than 300 percent more likely to fail the Danish army's intelligence test than native Danes. When it comes to the production of scientific work, the Islamic world produces less than 1/10 of the world average. Low average intelligence in the population and prioritizing faith over knowledge may also be the reason why fewer books have been translated into Arabic over the last 1,000 years than there are books translated into Spanish *in one year!*

On top of these mental complications comes the increased risk of many diseases related to genetic disorders leading to severe syndromes, handicaps, painful diseases, and decreased life expectancy.

Terror and violence: According to the Danish police, cousin-marriage is a cause for criminal behaviour because of low intelligence. This claim is confirmed by criminology research that long has established a connection between violent criminal behaviour and low intelligence.

It is also likely, that it is easier to convince people with low intelligence to follow the Islamic scriptures' hundreds of invitations and direct orders to harm, terrorize and wage war against people – including fellow Muslims, and even family members who do not following a literal interpretation of those scriptures.

Another link between Muslim inbreeding and terror concerns handicaps and mental diseases. Yusuf Yadgari of the Medical University of Kabul has autopsied the remains of suicide bombers and his findings support this theory. Yadgari found that close to ninety percent were suffering from severe illness such as blindness, cancer, missing limbs or leprosy. Many Muslim societies, including Afghanistan, have a low social acceptance of handicaps and severe illnesses. According to Yadgari, being physically handicapped or mentally retarded often leads to exclusion in a society like Afghanistan, and becoming a martyr might be the only chance of achieving social

recognition and honour — if not just a way to end the pain of being socially isolated (which is especially traumatizing in collectivist cultures like Islam). Al Qaida's use of people with Down's syndrome to commit terrorist attacks might be another unpleasant side effect of the many chromosomal illnesses that result from inbreeding between first cousins.

Ban cousin marriages?: A ban on consanguineous marriages is a win-win policy. It will save million of future children and their families from suffering. School leader Lise Egholm gives an example:

“One second grade class had a reading test. Fortunately most children did very well. However, a small Turkish boy only had two correct answers out of 40. The teacher was very concerned and asked me to attend the meeting with the mother. I looked at the student card and wondered that the family apparently only had one child. The mother said there had been three, but two died as infants because ‘we have bad blood’. She explained that her husband was her cousin, his parents were cousins and her own parents were blood related too. She also said, “You can not teach my boy much, but it’s good that he lives.” Soon after he was referred to a special school. This mother also told me that it was the men who were stupid because they want that “we marry our cousin, so we get bigger pieces of land, but they do not understand what we women know: that it is dangerous for the children if their parents are blood related.” ... I have encountered similar problems with Pakistani people and in Arab-speaking families.”

On top of these issues, tax payers would save billions from not having to handle the many costly societal challenges related to consanguineous marriage. Integrating into advanced cultures with our high-tech work market is not easy with an IQ of 75 and decreased social abilities.

Finally, it is at least possible that such a ban would decrease the amount of violence in our countries. Similar benefits would come from banning migrants with consanguineous background who apply for residence.

Whenever one points out that there is a worldwide movement that is gathering momentum away from the left, Marxism and globalism, towards a more human society based on tradition, culture, religion, patriotism, love of family and homeland, etc., the response is from the left is both predictable and invariable the same:

Okay, Brexiteers won, Trump won in America in a landslide, AFD is on the rise in Germany, you've your Freedom Party in Austria, you've Putin in Russia, Modi in India, Bolsonaro in Brazil, Viktor Orbán in

Hungary, the Law and Justice Party in Poland, Alejandro Giammattei in Guatemala (Who was elected in a landslide, taking over 60% of the vote, and has vowed to bring back the death penalty, stop migration, and oppose same-sex marriage and abortion), but it is all going to peter out.

And it is going to fizzle out because it's primarily animated by old white men who are dying off as we speak. And as they die off they're being replaced by this young idealistic Gen Z and a wave of beautiful woke-ness will flood the planet. So, my fellow liberals and lefties [you will hear BBC types purring] I promise you, just wait this out and we're going to see a beautiful, new, left-wing age arise ... and everyone will be reading the Guardian.

This theory is referred to by scholars as the cultural backlash thesis. It is best described as a sort of left-wing comfort blanket and is pushed by the likes of CNN, New York Times, the BBC, etc.

Gen Z are those born between 1997 and 2012, they're our youngest voting generation, so they're our current 18-year-olds. You will be told that Gen Z overwhelmingly hate Trump, are attached to characters like Bernie Sanders, support BLM, multiculturalism, LGBT rights, etc. It is certainly true that Gen Z is left-wing by a substantial majority on almost all issues, but this is only half the story. There's something much bigger going on and there is a big fly in this left-wing ointment, in fact, two big flies.

The first fly: whilst left-wing pundits gleefully inform us that recent polls show that only 30% of generation X self-identify as conservative, this is far from the full picture. What they fail to tell you is that similar polls conducted of the previous generation showed that only 22% of young people self-identified as conservative, and if you go back a couple of further generation to the baby-boomers, only 17% of young people were claiming to be conservative. So, despite what the BBC and its ilk would like to believe, the trend among young people is steadily away from the left-wing world view that it has been force fed them by Marxist activists pretending to be educators from the age of five, and by the mainstream media, and is steadily moving towards a more human national populist's world view.

As the father of a large family, it never ceases to astonish me just how ignorant of the teenage psyche are most teachers. For example, the school attended by one of my young grandchildren decided to crack down ruthlessly on what they called (but could not define) "homophobia" and started handing out draconian punishments to pupils for such trivia as calling a friend in good-natured jest a "faggot". The net result is that most of the pupils now detest homosexuals, whereas before the crackdown, homosexuals were barely on their radar. Anyone who has raised young teenagers would have foreseen the result of such misguided zealotry.

One big reason national populists have the leverage that will ultimately bury globalism, is that conservatives have children and left-wing liberals don't. And we are already beginning to see the fruits, of that: in the USA, where conservative religionists have a 30% fertility advantage over secularists. In just one generation, a population

that is split 50/50, if one half has a 30% fertility advantage, the split will become 60/40, and in two generations 75/25. Eric Kaufmann, professor of politics at Birkbeck College, University of London, argues that this will start to significantly affect global politics as early as 2030, when we will see conservative and religious sentiments starting to dominate our political and social scenes. Indeed, its effect can already be seen: in the USA, the left (the Democrats) lost on average 5% of its youth vote between 2012 and 2016!

The second fly in this left-wing balm is the false assumption of a static voter sentiment, i.e. how I vote at 18 is going to be the same way I vote when I am 40. Many of today's most prominent right-wingers were lefties when they were young. In fact, being left-wing when young is fairly normal. Some of this is hormonal: puberty brings with it a cocktail of hormones which leaves many teenagers uncharacteristically morose, and struggling to cope with irrational feelings of negativity and anger. These feelings sit well with a left-wing view of the world, which grows in the fertile soil of hatred for tradition, culture, the family, the nation etc. But we all know, both from our own experience of life and from observing others, that young people mature out of this. Furthermore, the data shows that conservative youngsters stay conservative, whilst left-wing young people tend to grow out of it. The traffic is by-and-large all one way.

Nearer home, Eric Kaufman has also analysed data from France. In the run-up to the French presidential election in 2017, Marine le Pen enjoyed support from almost 40% of French voters between the ages of 18 to 24 in the first round of voting. Now the significance of that percentage again can be seen when we compare the last time (and first time) le Pen ran, five years earlier in 2012, the support for her from those under the age of 25 was a mere 15%. So we've seen almost a tripling of her support among the youngest segment of French voters in a mere five years.

We saw similar results in the Austrian presidential election in December 2016. The Austrian Freedom Party garnished 42% of the votes of those under 29. In Germany, the ADF, the Alternative for Deutschland, have one of the youngest membership bases in German politics. In the Netherlands, nearly 25% of Dutch people under the age of 35 support Geert Wilders, the head of the Dutch Freedom Party in their last parliamentary election. In Greece, Golden Dawn received their strongest support from voters between the ages of 18 to 24. And in Poland (I don't have data for the latest election) in the 2015 elections, two thirds of voters between the ages of 18 to 26 cast their ballots for one of the three right wing parties, which is astonishing.

We also have data that shows that as populations age they get more conservative. Churchill said something to the effect that if you were Conservative before you were 30, you have no heart, but if you were liberal after 30, then you have no brains. There was a study published in 2014 in the Oxford Electoral Studies Journal that had tracked voters over several decades. They were actually able to quantify this phenomenon. The study followed the same people over several decades, and what they

found was that as each year passed there was a half percent increase in support for a conservative world view.

So there are your two flaws in the cultural backlash theory: 1) Generation “Z” is the most conservative generation since WW2, and 2) many of those who are not conservative we know will become so in time.

TRADITION - REBUILDING ON THE WASTELAND

The Traditional Orders are little by little rebuilding in the Catholic wasteland fashioned in the UK, first by the Protestant “Reformation” and then by Vatican II.

Another young man, also from their youth group in London, was admitted to try his vocation with the Redemptorists of Papa Stronsay in the Orkney Islands, in the far north of Scotland. And two more young men are about to start a year of discernment to the sacred priesthood.

On the one hand, we can but mourn the flight of our daughters and sons to foreign lands, for they wouldn't have needed to leave our shores if they had found the answer to their soul's thirst among our few remaining English monasteries, convents, and seminaries. On the other hand, we must thank God for providing them with solutions to their calling. It wouldn't be the first time that British youth have had to go overseas for religious formation. In penal times, hundreds of our best travelled to the Continent (France, the Spanish Netherlands, Italy and Spain) to pursue their religious vocation. Many of those young priests, on returning clandestinely to England, died as martyrs - thus sanctifying English soil with their blood.

Are they truly gone anyway? No one is remote if he lives in God. In truth, our one common dwelling is God's holy will. Anyone entering this spiritual realm will find it resounding with the songs of innumerable kin, regardless of physical distance, an anticipation here below of heaven.

Thank God for these young people. Please God, let many more be called! Let many more answer! These young people are the glowing embers from which Catholic England will be rekindled. They are the ones rebuilding the wasteland. Let us pray and sacrifice for many more.

The world in which we find ourselves living is, to use an expression from the Gospel, "in se divisum" (Mt 12:25). This division, it seems to me, consists of a split between reality and fiction: objective reality on one side, and the fiction of the media on the other. This certainly applies to the pandemic, which has been used as a tool of social engineering that is instrumental to the Great Reset, but it applies even more to the surreal American political situation, in which the evidence of a colossal electoral fraud is being censored by the media, which now proclaims Joe Biden's victory as an accomplished fact.

The reality of Covid is blatantly in contrast with what the mainstream media wants us to believe, but this is not enough to dismantle the grotesque castle of falsehoods to which the majority of the population conforms with resignation. In a similar way, the reality of electoral fraud, of blatant violations of the rules and the systematic falsification of the results contrasts with the narrative given to us by the information giants, who say that Joe Biden is the new President of the United States, period. And so *it must be*: there are no alternatives, either to the supposed devastating fury of a seasonal flu that caused the same number of deaths as last year, or to the inevitability of the election of a candidate who is corrupt and subservient to the *deep state*. In fact, Biden has already promised to restore the lockdown.

Reality no longer matters: it is absolutely irrelevant when it stands between the conceived plan and its realization. Covid and Biden are two holograms, two artificial creations, ready to be adapted time and time again to contingent needs or respectively replaced when necessary with Covid-21 and Kamala Harris. The accusations of irresponsibility thrown at Trump supporters for holding rallies vanish as soon as Biden's supporters gather in the streets, as has already happened for BLM demonstrations. What is criminal for some people is permitted for others: without explanations, without logic, without rationality. The mere fact of being on the left, of voting for Biden, of putting on the mask is a pass to do anything, while simply being on the right, voting for Trump or questioning the effectiveness of masks is sufficient reason for condemnation and an execution that does not require any evidence or a trial: they are *ipso facto* labeled as fascists, sovereignists, populists, deniers – and those labeled with these social stigmas are supposed to simply silently withdraw.

We thus return to that division between good people and evil people, that is ridiculed when it is used by one side – ours – and conversely held up as an incontestable postulate when used by our adversaries. We have seen this with the contemptuous comments responding to my words about the “*children of Light*” and the “*children of darkness*,” as if my “*apocalyptic tones*” were the fruit of a ravingly mad mind and not the simple observation of reality. But by disdainfully rejecting this Biblical division of humanity, they have actually confirmed it, restricting to themselves alone the right to give the stamp of social, political, and religious legitimacy.

They are the good ones, even if they support the killing of the innocent – and we are supposed to get over it. *They* are the ones supporting democracy, even if in order to win elections they must always resort to deception and fraud – even fraud that is blatantly evident. *They* are the defenders of freedom, even if they deprive us of it day after day. *They* are objective and honest, even if their corruption and their crimes are now obvious even to the blind. The dogma that they despise and deride in others is indisputable and incontrovertible when it is *they* who promote it.

But as I have said previously, they are forgetting a small detail, a particular that they cannot understand: the Truth exists in itself; it exists regardless of whether there is someone who believes it, because the Truth possesses in itself, ontologically, its own reason for validity. The Truth cannot be denied because it is an attribute of God; it is God Himself. And everything that is true participates in this primacy over lies. We can thus be theologically and philosophically certain that these deceptions' hours are numbered, because it will be enough to shine light on them to make them collapse. Light and darkness, precisely. So let us allow light to be shed on the deceptions of Biden and the Democrats, without taking even one step back: the fraud that they have plotted against President Trump and against America will not remain standing for long, nor will the worldwide fraud of Covid, the responsibility of the Chinese dictatorship, the complicity of the corrupt and traitors, and the enslavement of the *deep church*. *Tout se tient* [Everything fits together].

In this panorama of systematically constructed lies, spread by the media with a disturbing impudence, the election of Joe Biden is not only desired, but is considered indispensable and therefore true and therefore definitive. Even though the vote counts are not completed; even though the vote verifications and recounts are only just beginning; even though the lawsuits alleging fraud have only just been filed. Biden *must* become President, because *they* have already decided it: the vote of the American people is valid *only* if it ratifies this narrative – otherwise, it is “reinterpreted,” dismissed as plebiscite drift, populism, and fascism.

It is therefore not surprising that the Democrats have such coarse and violent enthusiasm for their candidate *in pectore*, nor that the media and the official commentators have such uncontrollable satisfaction, nor that political leaders from around the world are expressing their support and sycophantic subjection to the *deep state*. We are watching a race to see who can arrive first, elbowing and sprawling to show off, so that they can be seen to have always believed in the crushing victory of the Democratic puppet.

But if we understand that the sycophancy of world heads of state and party secretaries is simply a part of the trite script of the global Left, we are frankly left quite disturbed by the declarations of the United States’ Conference of Catholic Bishops, immediately republished by *Vatican News*, which with disturbing cross-eyedness credits itself with having supported “the second Catholic President in the history of the United States,” apparently forgetting the not-negligible detail that Biden is avidly pro-abortion, a supporter of LGBT ideology and of anti-Catholic globalism. The Archbishop of Los Angeles, José H. Gomez, profaning the memory of the *Cristeros* martyrs of his native country, says bluntly: “*The American people have spoken.*” The frauds that have been denounced and widely proven matter little: the annoying formality of the vote of the people, albeit adulterated in a thousand ways, must now be considered to be concluded in favor of the standard-bearer of aligned, mainstream thought. We have read, not without retching, the posts of James Martin, S.J., and all those courtiers who are pawing to get on Biden’s chariot in order to share in his ephemeral triumph. Those who disagree, those who ask for clarity, those who have recourse to the law to see their rights protected do not have any legitimacy and must be silent, resign themselves, and disappear. Or rather: they must be “united” with the exultant choir, applaud and smile. Those who do not accept are threatening democracy and must be ostracized. As may be seen, there are still two sides, but this time they are legitimate and indisputable because it is *they* who impose them.

It is indicative that the U.S. Conference of Catholic Bishops and Planned Parenthood are both expressing their satisfaction for the presumed electoral victory of the same person. This unanimity of consensus recalls the enthusiastic support of the Masonic Lodges on the occasion of the election of Jorge Mario Bergoglio, which was also not free from the shadow of fraud within the Conclave and was equally desired by the *deep state*, as we know clearly from the emails of John Podesta and the ties of Theodore McCarrick and his colleagues with the Democrats and with Biden himself. A very nice little group of cronies, no doubt about it.
